Application rate of mixed solution: 20ml per 1m²

ALWAYS pre-clean heavily soiled items and surfaces.

pH at recommended dillution: 2,35

Only use on hard non-porous surfaces such as plastc, vinyl, linoleum, glass, plated or stainless steel, aluminium, chrome, glazed porcelain, glazed tile, laminated surfaces, etc.

ADI has a mild ozone-like odour with a slightly salty taste. After application of ADI no residue is left behind on surfaces.

When used as directed ADI has an Oxidation Reduction Potential (ORP) of more than 950 mV for 7 days.

Once diluted at the correct dosage, the diluted solution has an effective shelf life of 7 days in a closed container.

Expiry Date: See sachet – (24 months after date of manufacture).

Keep container closed when not in use.

Ensure application equipment nozzles are plastic, stainless steel or aluminium.
